Frequently Asked Questions (FAQ)

Q: What should I do if I or my company have former industrial estate/land name on our

official documents such as the house registration, company's affidavit, the certificate

of value added TAX registration?

A: There are two options here;

1. You can proceed to change the name of the new industrial estate/land in your

official documents at the relevant government agency/or

2. You can continue to use existing industrial estate/land name in your official

documents until the official announcement of name of the new industrial estate.

Q: What should I do if our licensed documents, issued by the Industrial Estate Authority

of Thailand (IEAT), such as Land Use and Operation Permit, still have former industrial

estate/land names on them?

A: The original license is still valid by law. You can use the current license without any

problem. However, the new industrial estate/land names will be updated at the next

license renewal process.

Q: Do I need to update industrial estate/land names in my marketing materials such as

website, brochure, factsheet and etc?

A: You can immediately use the new industrial estate/land name on your company's
